Committee Reports

<u>Fundraising Team</u>

- 2020 grant of \$25k from Bessemer Trust received February 19
 - a confidential individual supporter who said the annual amount will continue as long as they are able
- Borealis Philanthropy Covid-19 funding \$5,900 received April 21

- Texas Pride Impact Funds \$3,000 for Covid-19 assistance received May 5
- Trans Justice Funding Project \$2500 for Covid-19 assistance received July 12

Action Team: Anti-violence Committee

- General—in August, discussed our work with the Maryland Anti-Violence Project because they are needing information about trans-specific anti-violence work and prison issues
- Project 1-documenting violence: no interest by volunteers at this time
- Project 2-document update assistance:
 - \circ $\,$ no awards in 2020 so far $\,$
 - still considering simplifying to increase participation and make it easier to manage
- Project 3—street outreach
 - was primarily done by Browning, so not a lot done this year
- Project 4—Dallas Trans Justice Project
 - no progress due to no time to put into it
 - have removed some of the action items due to questions about whether these might increase police violence, and due to another group being confused and wanting to use

Action Team: Healthcare Committee

- Project 1—health forum series: inactive
- Project 2—annual health fair: inactive
- Project 3—understanding anti-trans stigma impacts to healthcare access
 - all trans person interviews done
 - all healthcare provider interviews done
- Project 4—COVID-19 Financial Assistance project
 - proposal developed and approved by board by email confirmation
 - \$10,783 awarded of the total 11,400 granted, \$200 approved but not sent due to problems, leaving about \$1,000 left of allocated \$12,000
 - the approval process and logging is very fast and easy in general
 - one problem identified, but not too big of a problem
 - noted that most of the awards not to identifying trans and queer persons, but some seemed affiliated with the community (no specific count)
 - suggestions for how to open back up for the remainder \$1,000? Community request only?

Action Team: Housing Committee

- Project 1–Dallas Trans Shared Housing: inactive due to abuses from providers
- Project (unassigned)—Emergency Shelter Project
 - one award in 2020 for one week
 - had to close the project due to lack of time and concerns about safety at provider

Action Team: Prison Support

- No project number
 - prison data explorer: 433 unique views, average time on page about 5 minutes
 - $\circ\quad$ 2020 Q2 busiest quarter to date with almost 1300 letters in and out
 - appear to have over 200 new correspondents since March
- Project 2—Project 103:
 - December 4, 2019, filed suit against Texas for Project 103, but there was a technical issue and was refiled March 16, 2020
 - UT Austin School of Law Human Rights Clinic contacted about 400 of our persons with a survey, doing report on international human rights issues supported by survey results showing negative outcomes for refuse to use affirming identification
- Project 4—post release volunteer stipend
 - stipends to Mindy 2019 and January though part of March (ended due to coronavirus)
