Action Team: Prison Support

- We are still able to keep up with the prison letters, backlog about 30 days.
- Have continued to submit PREA audit deficiency comments to DOJ; have tried to gradually
 improve the comment document to make it more accessible for general public (legislators
 and others who may be interested).
- Have started compiling data from all PREA reports for Texas prisons for a report about the status of PREA in Texas (have requested what the PREA Resource Center has, and they seem to have nothing but what is online, which is minimal).
- Working on online data component so this can be made public.
- Still working on compiling housing resources for persons being released as I have time.

Action Team: Healthcare Committee

- Parkland Discrimination Project
 - Finally received response from HHS FOIA office after still more requests and notifying NARA.
 - HHS OCR did no real investigation other than to ask Parkland to provide policy.

Unfinished Business

- Board member elections: held annually, must have three minimum.
